- 7. No heavy truck traffic shall be permitted as part of this permit.
- 8. Drainage shall be maintained onsite and not affect adjacent properties.
- 9. Snow storage shall be maintained onsite or hauled to an approved snow storage facility.
- 10. The existing deck will be allowed to remain as is, in accordance with Text Amendment Bylaw No. 2023-14, once the bylaw receives three readings from Council and final approval from the Ministry of Government Relations.
