

# Bylaw No. 2019 – 31

R.M. of Edenwold No. 158 in the Province of Saskatchewan

## A Bylaw to Regulate the Use of the Water Tank Filling Station in the Municipality

The Council of the Rural Municipality of Edenwold No. 158 in the Province of Saskatchewan enacts as follows:

1. In this Bylaw:
  - (a) "Bylaw Enforcement Officer" means persons hired or employed by the Municipality to enforce the bylaws.
  - (b) "Council" means the Council of the Rural Municipality of Edenwold No. 158.
  - (c) "Municipality" means the Rural Municipality of Edenwold No. 158.
  - (d) "Property" means the truck fill station located at 11 Percival Drive, Great Plains Industrial Park, Emerald Park, Saskatchewan (MR21).
  - (e) "Water vending machine" means the device that has been installed by the Municipality for the purpose of dispensing water for a consumption charge to the public at 11 Percival Drive, Great Plains Industrial Park, Emerald Park, Saskatchewan (MR21)
2. No person shall deposit or cause to be deposited in the water vending machine any device, card, metal or plastic or other substitution for the proper tender or deface, injure, tamper with or impair the usefulness of the water vending machine.
3. No unauthorized persons shall enter or attempt to enter the building in which the water vending machine is located.
4. No person shall post a sign on the water vending machine without the approval of the Municipality. No person shall deface or remove any sign that has been approved by the Municipality.
5. No person shall:
  - (a) park a chemical spray apparatus; or
  - (b) park a truck or similar transport vehicle that contains full or used chemical containers, pumps, hoses or other equipment used in conjunction with a chemical apparatus; or
  - (c) have any chemical or chemical containers sealed or otherwise within 50 metres fo the property where the water vending machine is located at 11 Percival Drive, Great Plains Industrial Park, Emerald Park, Saskatchewan (MR21).
6. Any person who contravenes any of the provisions of this Bylaw or fails to comply therewith or with any notice given thereunder shall be liable to the penalties as herein provided.
  - (a) The penalty for breach of any of the preceding sections shall on summary conviction be Two-thousand dollars (\$2,000.00).
  - (b) Where a person has committed or is alleged to have committed a breach of any provisions of this Bylaw, a ticket in Form "A" attached to and forming part of this Bylaw may be served on such person by the Bylaw Enforcement Officer requiring him to pay to the Municipality the sum of Five hundred dollars (\$500.00). If payment is received within seven (7) days from the date of the issuance of the ticket, and accepted, then the person shall not be liable for further court action.
7. Where a Ticket in Form A has been deemed to have been issued improperly or in error, Council has, by way of a resolution, the only authority to cancel the Ticket.
8. Water shall be dispensed from the vending machine as follows:
  - (a) A water consumption charge for a uniform volume rate for each cubic metre of water shall be Three dollars and seventy five cents (\$3.75).
9. Bylaw No. 2015-27 shall be repealed.
10. The rates and charges contained in this Bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee, Saskatchewan Municipal Board.
