## Early tax payment discounts apply:

(on municipal portion only)

**5%** discount if paid by September 30th

**4%** discount if paid by October 31st

**2%** discount if paid by November 30th

## Options for Tax/Utility Payments:

- Cash - Pay in-person during regular office hours.
- Cheque - Pay as with cash, or mail in your payment.
- Debit - Check your debit limit before visiting the office.
- Online Credit Card Payments - Through "Plastiq"
- Online Bill Payment - Via financial institution only

Online payments must be made a minimum of 4 business days prior to any due date. For mailed payments the post-mark is not acceptable. Note: E-Transfers not accepted.

Property taxes will be levied in August and are due by December 31, 2026
