Community Safety Officer Donna Wall presented the Crime Prevention Through Environmental Design (CPTED) Initiative proposal. This initiative is a multi-disciplinary approach to crime prevention that uses urban and architectural design and the management of built and natural environments. CPTED can be introduced to the community through a social media platform by creating an online questionnaire for residents to identify if their property has vulnerable areas which could be subject to crime. The RM will post the online questionnaire on the RM's Facebook page, coordinate its release with Safety Week in May 2025, and share the post with the RM158 Rural Crime Watch Group.



Town of Balgonie: Request for Capital Purchase Contribution for Balgonie Fire Department
