Deputy Reeve Kotylak noted the time being 10:02 a.m. and called the Public Hearings to order.

# Bylaw No. 2025-12: Zoning Bylaw Text Amendment - Hydrovac Waste Disposal Facilities

Deputy Reeve Kotylak announced Bylaw No. 2025-12 being a bylaw to amend Bylaw No. 2019-20 known as the Zoning Bylaw by adding "hydrovac waste disposal facility" as a use to the Zoning Bylaw with associated development standards.

Deputy Reeve Kotylak asked for written submissions in regard to Bylaw No. 2025-12. Manager of Planning & Development Paige Boha advised that there were no written submissions received.

Deputy Reeve Kotylak asked for any verbal submissions. Mark Ferner, owner of Thomas Sand & Gravel, advised that they currently accept hydrovac mud at their gravel pit and they are on a sensitive aquifer. They only accept clean waste and get documentation in a responsible manner. The clean waste is dumped into clay lined pits and is then used to reclaim their pit. Mr. Ferner noted that there is a large sewer site (Pilot Butte lagoons) within a mile of their site. Mr. Ferner believes their business

operates responsibly and are very selective as to which companies they will allow to dispose clean waste at their site.

His concerns related to the current unsightliness of the property, especially given the prominent location at the entrance to Emerald Park, and potential safety concerns if dangerous materials are stored in the shipping containers.
