### Terms and Conditions:

1. The custom work rate is \$225.00/hr plus applicable taxes, for a minimum 30-minute contract. This rate applies to the use of the RM Motor Graders or Front-end Loader. Other equipment rates are as outlined in *Saskatchewan Heavy Construction Association (SHCA) Equipment Rental Rates & Membership Roster, 2024 Ed.* as requested and may be undertaken at Council's discretion.
2. I will pay for the work at the rates prescribed by the RM for custom work at the time the work is completed and invoiced accordingly and subject to all applicable fees or penalties.
3. I understand to advise the RM of the location of any items which may not be apparent upon visual inspection of the property, including but not limited to wells, cables, survey monuments, and any underground lines.
4. Should I fail to advise the RM, I agree that I will be obliged to compensate the RM for any resulting damage to the equipment used and to indemnify and save harmless the RM of and from any and all claims resulting from the equipment coming into contact with such items, including claims for consequential losses.
5. I agree to be present while the work is being done or contact the RM for a date/time for the work to be done. Should I not be present, it shall be presumed that the work has been done to my satisfaction and that it took the amount of time indicated by the Operator, as shown below.
6. It is acknowledged that the RM is acting as an independent contractor, and no employment relationship is intended to be created by this Agreement. The RM and the applicant also acknowledge that this Agreement does not create a partnership or joint venture between them and is exclusively a contract for service.
7. The RM will have no liability to the applicant or any other party for any loss or damage, whether direct, indirect, or consequential, which may arise from the provision of the Services.
