He advised that a site in the north central portion of the municipality had potential for a suitable site, however, advised that the project was in a very preliminary stage.

At 10:30 a.m. Nish Prasad and Al Dlugan of SaskWater met with Council to discuss a revised plan for installation of a raw water line to service the Town of White City. The amended route includes placement of the line in the municipal road allowance with a diversion into a 5-meter easement on the SW 27-18-17-W2, which will be obtained in conjunction with the development of said land. Mr. Dlugan indicated that the project would be tendered, with a mid to late-summer start date. Council had no objection to the amended route.

Mr. Slater will meet with the Foreman and Municipal Engineer to review any road or culvert deficiencies.
