



Minutes of the Special Budget Meeting of the Council of the Rural Municipality of Edenwold No. 158 held in the Municipal Office in Balgonie, Saskatchewan on Thursday, June 13th, 2013 commencing at 12:30 p.m. with the following members of Council present:

- Call to order Reeve Mitch Huber called the meeting to Order at 12:30 p.m.
- Budget 333 **SAUER:** That we adopt the 2013 operating and capital budget attached to and forming a part of these minutes, and the Administrator be hereby authorized to levy a municipal mill rate of 7 on all the taxable assessments in the municipality. **CARRIED.**
- Other 334 **HUBER:** That we conduct other business at this meeting. **CARRIED UNANIMOUSLY.**
- Bylaw 32 335 **JOYCE:** That Bylaw No.2013-32 being a bylaw to set Levies for the purpose of providing Waste Collection services pursuant to section 312 of *The Municipalities Act*, be given first reading. **CARRIED.**
- Bylaw 33 336 **CAPNERHURST:** That Bylaw No.2013-33 being a bylaw to set Levies for the purpose of providing Street Light service pursuant to section 312 of *The Municipalities Act*, be given first reading. **CARRIED.**
- Bylaw 34 337 **STRUDWICK:** That Bylaw No.2013-34 being a Bylaw to Establish Mill Rate Factors pursuant to section 285 of *The Municipalities Act*, be hereby given first reading. **CARRIED.**
- 338 **CAPNERHURST:** That Bylaw No.2013-34 being a Bylaw to establish Mill Rate Factors pursuant to section 285 of *The Municipalities Act*, be hereby given second reading. **CARRIED.**
- 339 **RADMACHER:** That as per section 103(4) of *The Municipalities Act*, Bylaw No.2013-34 be given three readings at this meeting. **CARRIED UNANIMOUSLY.**
- 340 **SAUER:** That Bylaw No.2013-34 being a Bylaw to Establish Mill Rate Factors pursuant to section 285 of *The Municipalities Act*, be given third and final reading. **CARRIED.**
