Royal Park Pre-Engineering Reports - Final Review

THAT we hereby approve the Royal Park Pre-Engineering Package with the following conditions:

Water

• Upon the sale of any lot within the Royal Business Park (Prairie View Business Park) prior to the installation of the 250mm watermain through the Royal Park residential community, the developer shall inform buyers (end clients) that the capacity provided by the water distribution system is currently limited and may not meet the requirement for individual fire protection systems of commercial/industrial properties and therefore, property owners are urged to assess their fire protection needs at the time of development to determine whether additional private fire protection components, such as a cistern and fire pump, are needed to meet individual demands.

Wastewater

- A correction is made to the statement in Section 4.1.3.1 that states that "the only wastewater currently being directed to the BRLS is from the upstream RM lift station... the BRLS is operating at 25.0L/s" to include Aspen Village and other developments contributing by gravity down Emerald Park Road, equaling 2.1 L/s and therefore the BRLS is currently operating at approximately 27.1 L/s;
- The developer provides a clear capacity limitation for the forcemain extension in Betteridge Road (known as the Phase 1 forcemain) to ensure it is clear when the new forcemain to connect the Royal Park Lift Station directly with the wastewater treatment facility is required to be installed and also to ensure the RM has adequate capacity for other developments beyond Royal Park; and,
- The developer recognizes that there is not currently any wastewater treatment capacity available to accommodate the development via the WCRM158 Wastewater Management Authority's treatment facilities.

Stormwater

- The developer will work together with the RM with respect to the design of the Emerald Park Lagoon Pond and any other ponds to be constructed on municipal property;
- The developer will ensure that the storm water system is constructed with adequate capacity to accommodate the water from Emerald Park and White City

that has historically and continues to travel through the Picasso Pathways lands into the Royal Park lands;

- The developer will ensure potential buyers in the business park are aware of the requirements for on-site storage of stormwater equal to a 50mm depth of water across the full area of the lot; and,
- The developer will work together with the RM to accommodate the larger culverts in Betteridge Road and provide assistance to the RM as needed to obtain a municipal easement through the lands to the south of Betteridge Road to accommodate the stormwater flows.

Transportation

- The developer will work with the RM to evaluate different roadway/intersection upgrade options for all potentially-affected RM roadways;
- The developer will work with the RM to develop a cost-sharing model that
 provides for equitable contributions from affected developers for required
 roadway/intersection upgrades in the RM, including for lands located within the
 jurisdiction of the Town of White City that are serviced by roadways in the RM;
 and,
- The developer will work with the RM to facilitate roadway right-of-way expansions, where required.
