**Update RM's Vaccination & Testing Policy**

Council meetings and any other public meetings or hearings being held by the municipality that are open to the public are considered public events, therefore subject to the Public Health Order. This means mandatory masking (effective September 17, 2021), and verification of proof of vaccination or negative covid test (starting Oct. 12, 2021).

For Citizens attending municipal offices to pay taxes, utilities or other municipal business, mandatory masking applies. As this is not an event, the municipality does not have to verify vaccination status on individual citizens looking for service.
