THAT we approve the discretionary use application for an Agricultural Industry Core Ag Inputs Ltd. business and instruct the Development Officer to issue a permit for the use at SW 17-17-17 W2 Ext TBD (the Lands) with the following conditions:

- 1. Development shall adhere to the September 28, 2022, letter from the Ministry of Highways Traffic Engineering and Development (Schedule D).
- 2. That this permit allows for development of the 1.1 ha (2.7 acre) site, with a 613 $\,\mathrm{m}^2$ chemical shed and a 232 m² office as per Agricultural Resource District (AR), attached. Any other use or intensification of use may require a separate development permit or discretionary use approval from Council. A pre-application meeting with the Planner/Development Officer is encouraged to verify use.
- 3. Building(s) shall be located as shown on the site plan attached to the permit, stamped, and dated August 9, 2022.
- 4. All existing features within the RM right-of-way shall be returned to their original condition upon completion of work.
- 5. Building elevations, culvert size shall conform to the standards and requirements of the site drainage plan prepared by WCE Design Inc., stamped, and dated August 9, 2022.
- 6. Site grading and drainage shall conform to a drainage plan to be submitted and approved by the RM in conformance with the regulations of the Water Security Agency.
- 7. The owner shall apply to Water Security Agency for a permit to conduct ground water investigation, water a rights licence and approval to construct and operate works if planning to drill a well. The owner shall also develop best management practices a mitigation plan to minimize spills of agricultural spills into the subsurface. These reports shall be supplied to the RM.
- 8. The landowner must provide:
- a. That all mains, pipe fittings, valves and equipment are installed in strict accordance with manufacturer's recommendations.
 - b. "As-built" drawings showing the location of water and sanitary sewer installed

accompanied by Saskatchewan Health Authority approvals.

- 9. No building shall be constructed until a building permit has been issued.
- 10. Prior to use and occupancy of the building the Development Officer requires:
- a. Confirmation that the civic address, TBD, has been posted on the front of the building, is not obstructed from view, is not smaller than 8" in height and is a contrasting color to the building to provide visual clarity.
- b. "As-built" drawings confirming that the building has been constructed in accordance with conditions 5 and 8b.
 - c. A final landscaping plan.
- 11. This permit is subject to the standards and requirements of Provincial regulations and other municipal bylaws.
- 12. Approach permits shall be obtained from the RM prior to any development taking place at the site.
- 13. Dust proofing of the site and of Range Road 2175 may be required of to ensure traffic safety.
- 14. Signage prohibiting southbound traffic on Range Road 2175 is recommended and will be at the cost of the applicant.
- 15. Development at this location shall not cause a nuisance or offence or both:
 - a. By the creation of noise or vibration;
 - b. By the emission of light and glare;
 - c. By reason of emission of gas, fumes, smoke, dust, or objectionable odour;
- d. By reason of the unsightly storage of goods, wares, merchandise, salvage, refuse matter, motor vehicles, trailers, or parts of vehicles or trailers, machinery, or other such material; or
 - e. By any combination of things in this subsection.
- 16. Landscaping must be installed within two (2) years in accordance with the final landscaping plan.
- 17. No person shall cause or permit any lands or buildings to become untidy or unsightly (Bylaw No. 2021-44).
