- 6. Must comply with all Development Regulations and requirements of the Country Residential District (CR2) (Bylaw No. 2022-41).
- 7. Hours of operation shall be 08:00-18:00, Monday through Friday, unless otherwise requested.
- 8. Any variation to this permit, intensification of use, change of hours of operation, change of use, or addition of staff may require a separate development permit or discretionary use approval from Council.
- 9. A building permit may be required for renovations to the detached accessory building.
- 10. No nuisance from noise, vibration, smoke, dust, odours, heat, glare, electrical or radio disturbance shall be produced by the major home-based business, and, at all times, the privacy and enjoyment of adjacent dwellings shall be preserved. The major home-based business shall not adversely affect the amenities of the neighbourhood.
